This matter being heard pursuant to the provisions of Section 123-121, Oregon Compiled Laws Annotated, upon the report of the Commissioners, and the Court finding that the Commissioners heretofore appointed thereafter duly qualified and discharged their duties in all respects as required by law, and on April 3, 1942 duly filed herein their report, and that notice of the filing of their report was duly published, and that due proof of such publication has been made herein, and that May 25, 1942 was the last day on which Sauvie Island Drainage District or any owner of land in said District might have filed exceptions to said Report or to any assessment for either benefits or damages, and that no such exceptions have been filed herein by said District or by any such owner of land, and the Court having examined the report and further finding that it is in all respects true and correct and in conformity to law, and that no amendment or modification of said report should be made, and the Court having examined under oath as a witness the Chairman of said District's Board of Supervisors, and further finding from the proof submitted that the estimated cost of the improvement contemplated in the "Plan for Reclamation" is less than the benefits to be derived therefrom, good cause appearing therefor, now, therefore, it is

CONSIDERED, ORDERED, ADJUDGED AND DECREED that said Commissioners' report be and the same is approved and confirmed hereby in all things and that a certified copy of this decree and a certified copy of said

Commissioners' Report as confirmed by this Court shall be transmitted by the County Clerk to the Secretary of the Board of Supervisors of said District, and to the Recorder of Multnomah County where the same shall become a permanent record, and to the Recorder of Columbia County where the same shall become a permanent record, and that for five (5) years from the date hereof jurisdiction herein be and it is hereby reserved and retained by the Court over said Board of Commissioners and over the subject matter of their report, and that for such period of five (5) years said Commissioners be and they are kept hereby subject to the further orders of the Court herein to perform such supplemental administrative duties as Commissioners as may be contemplated by law and as may be directed by the orders of the Court.


